SECTION IV HEALTH INFORMATION

EYE CONTACT: This product is presumed to be moderately irritating to the eyes. Prolonged contact may result in chemical burns.

SKIN CONTACT: Exposure may produce mild to moderate skin irritation. Prolonged contact may result in dermatitis and chemical burns.

INHALATION: Product vapors/mists are corrosive to the nose, throat, and respiratory tract. As a result of repeated overexposure or exposure to a single large dose, individuals may develop lung sensitization to amines, polyamines, polyamides, and related compounds which may cause them to react to a later exposure at levels well below the TLV. Once an individual is diagnosed as being sensitized, no further exposure can be permitted. This lung sensitization may be either temporary or permanent.

INGESTION: This product is corrosive and may result in chemical burns to the gastrointestinal tract.

SIGNS AND SYMPTOMS: Symptoms of eye irritation include pain, tearing, reddening, and swelling. Symptoms of skin irritation include reddening, swelling, rash, and redness. Symptoms of respiratory irritation include runny nose, sore throat, coughing, chest discomfort, shortness of breath, and reduced lung function. Symptoms of gastrointestinal irritation include sore throat, abdominal pain, nausea, vomiting, and diarrhea. Skin sensitization results in allergic dermatitis which may include rash, itching, hives and swelling of extremities. Lung sensitization results in asthma-like symptoms: chest tightness, shortness of breath, wheezing and coughing. These symptoms may be immediate or delayed up to several hours.

AGGRAVATED MEDICAL CONDITIONS: Pre-existing skin, eye, and respiratory disorders may be aggravated by exposure to this product.

OTHER HEALTH EFFECTS: None recognized.

SECTION V EMERGENCY AND FIRST AID PROCEDURES

EYE CONTACT: If irritation or redness develops, move victim away from exposure source and into fresh air. Flush eyes with water for fifteen (15) minutes. If symptoms persist, seek medical attention.

SKIN CONTACT: Remove contaminated shoes and clothing. Cleanse affected area(s) thoroughly by washing with mild soap and water. If irritation or redness develops and persists, seek medical attention.

INHALATION: If respiratory symptoms develop, move victim away from exposure source and into fresh air. If symptoms persist, seek medical attention.

INGESTION: Dilute with liquid unless the victim is unconsciousness or very drowsy. If vomiting occurs spontaneously, keep the victim's head below the hips to prevent aspiration into the lungs. Consult a physician, hospital, or poison control center and/or transport to an emergency facility immediately.

SECTION VI FIRE AND EXPLOSION HAZARDS

SPECIAL FIRE FIGHTING PROCEDURES AND PRECAUTIONS: Clear area of unprotected personnel. Do not enter confined fire space without helmet, face shield, bunker coat, gloves, rubber boots, and a positive pressure NIOSH approved self-contained breathing apparatus.

UNUSUAL FIRE AND EXPLOSION HAZARDS: Containers exposed to intense heat from fires should be cooled with water to prevent vapor pressure buildup which may result in container rupture. SECTION VIII EMPLOYEE PROTECTION

SECTION IX ENVIRONMENTAL PROTECTION

SPILL OR LEAK PROCEDURES: LARGE SPILLS>> Evacuate the hazard area of unprotected personnel. Wear appropriate respirator and protective clothing. Shut off source of leak only if safe to do so. Dike and contain. If vapor cloud forms, water fog may be used to suppress; contain run-off. Remove with vacuum trucks or pump to storage/salvage vessels. SMALL SPILLS>> Take up with an absorbent material and place in non-leaking containers; seal tightly for proper disposal.
