## SECTION 5: FIRE AND EXPLOSIVES HAZARDS

**FLASHPOINT:** 105 °F

**EXTINGUISHING MEDIA:** Water fog, foam, dry chemical, or carbon dioxide.

**CHEMICAL/COMBUSTION HAZARDS:** Carbon monoxide, carbon dioxide, and incomplete combustion products.
