USES

PRODUCT DATA

Size: 20-80 mesh (850-150 microns); a range of sizes offsets the effects of traffic and binder degradation.

STANDARDS

Complies with Alberta Transportation Specification for Pavement Markings.

APPLICATION

To ensure optimum retroreflective performance and durability, the bead/binder system needs to be applied in the proper manner:

- Apply the spheres immediately following the binder application.
- Apply spheres evenly over the width and length of the marking.
- Embed the spheres to a level of 60%.
- Apply SAFETY SPHERES at the rate of:
2.72-3.63 kgs (6-8 lbs) per 3.78L (1 gal.) of Latex
9.07-10.89 kgs (20-24 lbs) per 3.78L (1 gal) of epoxy.
