Surface Preparation ... Surface shall be firm and free from loose particles, cracks, grease, oil, frost, snow, ice, and other foreign matter. Surface may be damp, but not wet. Prime with 50% diluted 520 SEALMASTIC. Dilute with clean water only.

Mixing ... Mix thoroughly before application.

Application Method ... Apply by brush, trowel, glove or sprayer. Protect uncured emulsion from precipitation. Protect walls with PROTECTION COURSE (VIBRAFLEX® PC) from W. R. MEADOWS during backfill operations.

Drying Time ... Touch dry: 2 hours. Firm dry: 24 hours.

Cleanup ... Use water for cleanup of uncured emulsion. Use mineral spirits for cleanup of cured emulsion.
